The Democratic Members of the Committee on Oversight and Government Reform (“the Committee”) are conducting an investigation in connection with multiple reports published in *The Atlantic* that several members of the National Security Council and the President’s Cabinet discussed highly sensitive, potentially classified plans for a military operation in Yemen on the Signal messaging application.¹ This incident, which reportedly took place through a Signal chat group named “Houthi PC small group,” raises immediate and deeply alarming concerns about the misuse of unsecured communication platforms and/or devices for sensitive discussions and the potential that American military and intelligence professionals may have been compromised by the reckless dissemination of potentially classified material. Because you were reportedly one of the participants in the “Houthi PC small group” chat, we require your participation in a transcribed interview to examine your involvement in this incident and other potentially reckless disclosures of highly sensitive national security information.²
