Dear Acting Assistant Commissioner Hayes:

Under the Trump Administration, federal immigration agents with U.S. Immigration and Customs Enforcement (ICE) and U.S. Customs and Border Protection (CBP) have engaged in violent, unlawful, and cruel tactics to carry out President Trump’s mass deportation campaign. CBP—which includes Border Patrol agents and customs officers—has traditionally operated at ports of entry and along the border. But CBP agents and officers have played an outsized role in interior immigration enforcement operations. Americans are horrified by these abuses and want accountability. Oversight Democrats have been documenting these actions in a public Immigration Enforcement Dashboard (the Dashboard) that now contains 677 incidents of possible abuse and misconduct.<sup>1</sup> These incidents, which have been verified through public reporting and case filings, represent an undercount of the widespread abuse and misconduct by federal immigration agents with the Department of Homeland Security (DHS). In accordance with your authority to investigate—and oversee the investigation of—criminal and administrative misconduct, we are submitting each incident to you for intake as individual complaints.<sup>2</sup>

Through bicameral spotlight forums, Oversight Democrats have heard directly from U.S. citizens who have been victims of this lawlessness. They have described being dragged from their cars, slammed to the ground, gassed with tear gas, held at gunpoint, and shot multiple times. They have described the killing of their family member. They have shared accounts of their car windows being smashed, with one describing how agents broke down the door to her home without a warrant while her child was inside. They have recounted unlawful detentions

without access to legal counsel. Parents have described agents aggressively detaining their children, holding them at gunpoint, and placing them in restraints. Adolescents have described being permanently separated from their deported parents, with one recounting how agents placed him in a chokehold. These Americans and their family members have been smeared, called domestic terrorists and criminals, and accused—without evidence—of impeding and assaulting agents. But contrary to President Trump’s lies, these individuals are not the worst of the worst<sup>3</sup>—they are law-abiding U.S. citizens. Their experiences represent the thousands of individuals—citizen and noncitizen alike—who have been harmed by DHS’s indiscriminate and violent mass deportation campaign. These people have been harmed and victimized by their own government and are entitled to justice and accountability.<sup>4</sup>

In a tacit admission that brutal and unacceptable behavior by CBP personnel had reached unacceptable levels, the Trump Administration took the dramatic step of removing Commander-at-Large Greg Bovino from his position prior to his retirement, with promises to pursue a “softer” approach in future.<sup>5</sup> While Bovino’s removal is a victory for oversight of the administration, it is not sufficient to ensure lawful and appropriate behavior by the agency.

These incidents reflect potential violations of constitutional and statutory law, court orders, and current DHS policies. Some are the product of unjustifiable changes to long-standing policy and practice (for example, detaining noncitizens at routine immigration interviews, immigration court proceedings, or ICE check-ins, and conducting enforcement actions at formerly protected places like schools, churches, and hospitals) that also raise potential violations of constitutional and statutory law, and deprive individuals of access to essential services. Oversight Democrats have classified these abuses and misconduct under five categories:

1. **Concerning Use of Force:** The Dashboard includes 265 entries involving use of force during immigration enforcement operations and in response to protest activity. These aggressive and violent uses of force include car rammings and window smashing, tackling, chokeholds, shootings, indiscriminate and excessive use of pepper spray and tear gas, and threats with a firearm, among others.
2. **Concerning Arrests/Detentions:** The Dashboard includes 509 entries involving potentially unlawful arrests and/or detentions, including stops based on racial profiling, warrantless arrests without probable cause, forcible home entries without judicial warrants, detention of individuals protected by deferred action, and arrests at routine immigration interviews or ICE check-ins.
3. **Enforcement Action at Sensitive Location:** The Dashboard includes 100 entries involving enforcement actions at locations previously designated as “sensitive” or “protected” under long-standing DHS policies.<sup>6</sup> For example, these cases include arrests and/or detentions and uses of force that occur at or near schools, hospitals, houses of worship, and courthouses.
4. **Concerning Deportation:** The Dashboard includes 21 entries involving deportations that have occurred in violation of court-ordered stays of removal, despite pending applications for legal status to remain in the United States, and with U.S. citizen children often deported alongside their noncitizen parents.
5. **U.S. Citizen:** The Dashboard includes 189 entries involving U.S. citizens. These cases involve all of the above categories, including violent uses of force, stops based on racial profiling, and deportations. Cases also include detentions and arrests of U.S. citizen protestors and observers based on unfounded claims of assault on federal immigration agents.

This conduct has not occurred in a vacuum. Since January 20, 2025, ICE, CBP, and other DHS officers and agents have taken these egregious actions in pursuit of the Trump Administration’s mass deportation campaign and at the encouragement of White House and DHS leadership. White House and DHS officials have stated that DHS personnel have “absolute immunity;” lied about this misconduct to the public, Congress, and the courts; reflexively defended personnel who have engaged in misconduct while smearing their victims; and allowed officers and agents to operate with masks and without identifying information.<sup>7</sup>

This culture of impunity must end. We expect that your office should already be familiar with and investigating these incidents. Given CBP's recent and outsized role in interior immigration enforcement operations, we expect that CBP should be able to identify which incidents involved CBP officers and agents. In accordance with your mission, we request that CBP OPR review each incident in Appendix A and provide a response to the below inquiries and document requests no later than May 4, 2026.<sup>8</sup>

1. For each incident in Appendix A, has an investigation or inquiry been opened into the incident? If so, provide the following:
  - a. Date opened;
  - b. Case identification number in CBP systems;
  - c. Lead investigative entity (e.g., OPR Investigations program, OPR National Fact Finder, Component supervisor);
  - d. Inquiry type (e.g., criminal investigation, administrative investigation, management referral, administrative inquiry);
  - e. CBP component (Border Patrol or Office of Field Operations) involved in the investigation/inquiry;
  - f. Current status of the investigation/inquiry (ongoing or closed); and
  - g. Outcome of the inquiry, if closed (e.g., substantiated, unsubstantiated, or unfounded).
2. CBP OPR's intake and complaint opening guidelines governing decisions on whether to open an investigation or refer an allegation to Component management or another entity for review, fact-finding, or investigation;

3. CBP OPR's policies, procedures, and trainings on conducting criminal and administrative investigations into officer and agent misconduct, including use of force; and
4. CBP's policies, procedures, and trainings on conducting administrative inquiries into officer and agent misconduct.

The American people demand accountability, and each incident deserves evaluation and justice. Please provide Committee Democratic staff with a briefing on the status of your work to investigate misconduct at CBP and any ongoing investigations.

The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
