RE: Proposed Rule – Regulation for Federal Financial Assistance [OPM-2026-10817]

Dear Director Vought:

We write with serious concern and strong opposition to the Trump Administration’s proposed rule to gut the federal grantmaking process, which would politicize all federal grant funding and subject billions of taxpayer dollars to overtly partisan purity tests. Federal grants drive lifesaving discoveries, serve as a lifeline for families and communities, and help address Americans’ needs and challenges on critical issues including public health, public safety, child care, education, and infrastructure. The proposed rule would allow the Trump Administration to allocate taxpayer dollars based on President Trump’s personal interests—not the best interests of Americans—and would open unprecedented opportunities for waste, abuse, and corruption. Politicizing federal funding in this way, including by banning grant funds for anything the Trump Administration determines to be “anti-American,” is clearly and alarmingly destructive, dangerous, and against the public interest.¹

The proposed rule, issued by the Office of Management and Budget (OMB) on May 29, 2026, would give senior political appointees broad power and discretion over the approval and termination of grants. It would institute new requirements that all federal grants be approved by senior political appointees who would be required to ensure that the funds “advance the President’s policy priorities.”² By moving decisions about grant funding into the hands of political appointees charged with a mandate to only fund projects and recipients that align with its partisan ideology, the Trump Administration is escalating its radical and unlawful attempts to seize broad, unilateral power.

The proposed rule would also expand the Administration's power to terminate grants without cause by finding that they are "no longer in the Federal Government's interest" and gives OMB and the White House direct visibility and oversight over specific institutions and organizations that receive grants.³ The proposed rule's requirements are highly prescriptive, ill-defined, overbroad, and designed to give the Trump Administration maximum power over virtually all aspects of American life. It goes so far as to ban grant funds from being used "to fund, promote, encourage, subsidize, or facilitate... initiatives that... promote anti-American values."⁴ The extraordinarily broad wording would leave the definition of what constitutes "American values" up to the discretion of President Trump and his Administration.

Giving insight into some of the countless ways the rule might be weaponized if finalized, the proposed rule also places highly political and specific strictures on grants, including banning grants from being used for work related to "diversity, equity, inclusion, and accessibility." The language further specifies that awards must not be used to "fund, promote, encourage, subsidize, or facilitate ... denial by the recipient of the sex binary in humans or the notion that sex is a chosen or mutable characteristic."⁵

The new requirements would drastically alter not just the review of grants in response to funding announcements, but also all future new federal programs which would be required to "align with administration policies and priorities."⁶ The proposed rule also sets forth restrictions on grant applicants and recipients that are ripe for weaponization. Grant recipients would be scrutinized for their "institutional affiliations,"⁷ their compliance with "religious liberty"⁸ laws, and if they have a "history of questionable practices."⁹

The proposed rule would also impose new requirements on Offices of Inspectors General (OIG) to share certain disclosures with the U.S. Attorney's Office for the District of Columbia within ten days of receipt.¹⁰ This requirement does not provide for the assessment of the credibility of disclosures by OIGs themselves and would compromise confidentiality and the integrity of potential investigations. Treating every complaint as valid and requiring OIGs to

refer all complaints to the Department of Justice would give a politicized Department of Justice even more latitude to weaponize unsubstantiated claims.

Politicized funding requirements would impact every organization and institution that receives any federal funds. The new requirements would hit scientific research and innovation especially hard, with scientific grants no longer reviewed by nonpartisan scientific experts, limits on what topics researchers can investigate, limits on who researchers can collaborate with, and broad discretion for the Trump Administration to terminate research projects midstream. Scientific research grants would instead be reviewed by political appointees forbidden from deferring to peer reviewers, granting them broad discretion to fund science based on political ideology rather than scientific rigor or merit.¹¹ The proposed rule's new requirement that all recipients and subrecipients participate in the Department of Homeland Security's E-Verify program would also create an undue administrative burden on businesses of all sizes as it would require recipients and subrecipients to report any adverse decision from the program to the awarding agency—effectively turning recipients of federal grants into another arm of the Trump Administration's draconian immigration crackdown.¹²

Since its earliest days, the second Trump Administration has illegally frozen, recklessly canceled, and spitefully weaponized federal grant funding with no regard for the consequences, which are most often borne by American families. It has unlawfully withheld funds appropriated by Congress to help hungry children, fight disease, and build a stronger economy.¹³ Instead of correcting its radical overreach and abuse of taxpayer dollars, OMB's proposed rule is a significant escalation of such overreach and abuse, seeking to provide the President with ultimate power to wield taxpayer dollars according to his own whims. As such, we demand that you immediately rescind the proposed rule and instead prioritize reforms that protect and advance the integrity of the federal grantmaking process.
