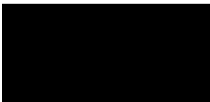

There is also no mention of major academic sponsorships such as CMI, Harvard, Xinhua etc. which we should add to the letter.

As proposed, please go ahead and start with the IIGCC letter and amend from there. We can also send the energy outlook, technology outlook and relevant SR materials to them.

Dominic, Paul,

I received a request from the Union of Concerned Scientists on Friday to complete a questionnaire about BP's climate-relevant policies and actions. The questionnaire (attached) apparently draws from existing resources (including CDP) but information captured here is very high level and exact sources are not referenced. The second of the two sections that makes up the questionnaire asks for detailed information about the positions of trade associations that we might be members of, their view on climate science and positioning relative to BP's and actions we have taken to address any differences.

They've requested a response by 2nd May for any response to be considered. Given the 2nd May is a bank holiday, this would need to be responded to by next Friday – 29th.

This seems to me to be a not-insubstantial request with zero warning and a tight turnaround (particularly when you consider legal and other checks) and I'm wondering how you might suggest this is addressed? My suggestion would be to respond with a letter that clearly states our position regarding climate (perhaps using the resolution as the framework for that) and lobbying more generally. We used a similar approach in response to a query from the IIGCC last year, although their request was far less prescriptive (response attached).

It feels to me that pushing back on these sorts of requests is reasonable and the proposal above an acceptable compromise, but I'd welcome your thoughts.

Dear Mr. Andrews,

I am writing on behalf of the Union of Concerned Scientists (UCS) to ask you to complete a questionnaire about BP's climate-relevant policies and actions by Monday, May 2, 2016.

UCS has outlined a set of expectations for fossil fuel producers to accept responsibility for climate change, contribute to solutions, and thereby regain their social license. These expectations fall into four broad areas:

- Full disclosure of the financial and physical risks of climate change;
- Support for fair and cost-effective policies to reduce global-warming emissions;
- Alignment of business model with a carbon-constrained world;
- Rejection of disinformation on climate science and policy.

UCS has developed specific indicators in each of these areas, drawing on existing resources such as CDP, the Science-Based Targets Initiative, the Oxford Martin Working Principles for Investment in Fossil Fuels, the CPA-Zicklin Index of Corporate Political Disclosure and Accountability, and the Guide for Responsible Corporate Engagement in Climate Policy.

We are assessing leading fossil fuel producers with significant U.S. presence against these indicators. These assessments will be published in a forthcoming report. I am contacting you, as Societal Risk Adviser, to request your help in ensuring that we have accurate, complete, and up-to-date information on which to base our assessments.

Attached you will find a questionnaire seeking your comments on our findings based on publicly available information about BP's climate-relevant policies and actions. We invite you to complete the survey in order to clarify publicly available information, make further disclosures, address outstanding questions, and point us to specific relevant webpages or reports.

- **Sections A through D (pp. 1-8)** focus on indicators related to the four broad expectations outlined above. Each section notes the sources on which UCS's findings in that area are based. Please enter your comments and recommend additional relevant sources in the spaces provided.
- **Section E (pp. 9-10)** focuses on relevant industry associations, trade groups, and climate action groups. For each group, please provide information about your company's affiliation, roles, and actions taken regarding to address any inconsistencies between the group's position on climate change and your company's position.

In order for information about your company's policies and actions to be reflected in this assessment, it must be publicly accessible by May 2, 2016.
