Subject: C&EA Fuels Team Bi-Weekly Report

Objective 1: Pass legislation to reform the RFS or regulation that resets the RFS mandate consistent with BP's agreed principles

Objective 2: Pass fuels policy legislation/regulation that protects/enhances BP's business environment

- **Georgia RVP** The Georgia Environmental Protection Division (EPD) is requesting an amendment to the Federal gasoline volatility rule to relax the summertime RVP in the former 13-county Atlanta designated volatility nonattainment area from 7.8 psi to 9.0, which would match the RVP requirements that apply to the rest of the state year-round. The proposed revision contains a technical analysis and an update to Georgia's 2008 Ozone Maintenance Plan, which demonstrates that the relaxation of the RVP

requirement will not interfere with the attainment or maintenance of any National Ambient Air Quality Standards or any other Clean Air Act (CAA) requirement as prescribed in section 110(l) of the CAA. After receiving zero negative comments on the proposed SIP, the EPD officially submitted the new SIP to the Environmental Protection Agency. The EPD hopes to have the updated SIP approved by the EPA in plenty of time before next summer's ozone season.

Objective 3: Consistent with Group policy, in priority states moving forward with carbon policies, influence outcomes in order to protect the role of gas, existing BP assets and to achieve sensible carbon pricing mechanism.

Objective 4: Improve the business environment at Cherry Point and the West Coast to underpin delivery of Cherry Point Asset Strategy

- **Whatcom County** The Whatcom County Council extended the six-month moratorium (for the fifth time) on new fossil fuel export facilities at Cherry Point as its August 8 council meeting. BP will discuss impacts and concerns related to pending changes to the Comp Plan and Whatcom County Code under consideration at an upcoming meeting of the Planning and Development Committee. Brady will speak to members of a local trade union to seek their continued support for growth and future development at Cherry Point.

- **Lead-Based Paint** Sherwin Williams and Con Agra are working with Senator Hertzberg to try to get a legislative deal done with one week to go in the session. Though it would not directly affect Atlantic Richfield Company, or require it to fund programs, a deal would be helpful as it fixes the nuisance definition coming out of the Santa Clara court case and, hopefully, puts the issue to bed by funding remediation in all 58 counties of the state. The bill would require a 2/3 vote of the legislature – a tall order in the last week of session.

Objective 5: Deliver meaningful communications so employees understand the business strategy and the role they play in delivery

Objective 6: Achieve timely receipt and aggressively defend all key permits

- **Whiting Fire Water Project** Wortham and leaders of the Fire Water Project Team met with the City of East Chicago to discuss the project and outline the review and permit submission and approval process. Wortham is working with legal to review and approve a project scope document that will be submitted to the City's Plan Commission.

- **Whiting Mayor Meeting** Mike Schwerha, Keilman and Wortham met with the Mayor of the City of Whiting to discuss ongoing and upcoming project within Whiting. There were several maintenance, real estate, public safety and development related take-away's following the meeting. Wortham has responsibility for follow-up.

- **Pipeline Repairs** Rybarczyk has helped address several concerns from a resident in Highland, IN whose yard is being used to access a pipeline repair work site. The resident had previously threatened to deny BP access or halt the job due to her concerns with the project. The Indiana Dept. of Natural Resources has expressed interest in contacting the media to praise BP's efforts to protect wetlands and other environmentally-sensitive areas adjacent to the project site. Rybarczyk is working with the BP Press Office to address that request. Meantime, Munster, IN officials have also praised BP for how it conducted a recently-completed repair project in that community. The repair required the closure of a main road through town for several weeks.

- **Hammond** Wortham met with City of Hammond Chief of Staff to discuss relationship development and establish an on-going meeting schedule. Wortham and Taillon will meet on a monthly basis to discuss upcoming and on-going BP related projects and community activities. Wortham and Taillon will tour the City of Hammond on Thursday, August 30th and have scheduled a joint meeting of BP's Maintenance and Emergency Services leader's, and the City's Police and Fire Chiefs and, the Streets and Sanitation Director on Wednesday, September 5th.

Objective 7: Execute integrated external communications strategy to promote/support retail growth strategy

- **WGN** The Press Office responded to an inquiry from a Chicagoland TV reporter regarding Amoco branded retail and is attempting to turn it into a feature story. Abendhoff invited the reporter to a Naperville site opening in late Sept./Oct along with an interview opportunity with Rick Altizer.

- **Tobacco** Moran worked with the ampm leadership to gather information and develop a potential strategy to approach a ban in the city of Sacramento on the sale of flavored tobacco products. ampm has 29 stores in the city of Sacramento. Moran reached out to Altria and the dealers association to share information and strategy. We do not want to appear pro-tobacco but do want to help our franchisees who may want to engage city council members to express their concerns. Moran and Cochrane also reached out to Retail leadership to set up a broader discussion on tobacco issues.

Objective 8: Develop and implement joint federal/state integrated communications & stakeholder engagement plan to counter off-oil/keep-it-in the-ground movement.

- **Toledo Community Bill of Rights (CBOR)** Caprella is working with, BP legal, API and local government leaders to assess and respond to a proposed CBOR amendment to the Toledo City Charter filed via "Toledoans for Safe Water." The amendment is targeted at agriculture and limited to the City of Toledo. Following conversations with BP, City of Oregon Administrator Mike Beazley engaged his counterparts and other key stakeholders in the City of Toledo on keeping this CBOR off the ballot. C&EA is working closely with API Ohio with the goal of keeping the initiative off the November 6 ballot. The Lucas County Board of Elections has tentatively scheduled a hearing for Tuesday, August 28 and is expected to reject the initiative.
- **Columbus CBOR** The Franklin County Board of Elections ruled in API's favor to not allow the Columbus CBOR issue to move forward on to the November ballot. The CBOR proposed to ban certain oil and gas activities within Columbus. The Board unanimously voted against the proposal as it is outside the scope of the city's authority.

- **Walk the Line Protest** Rybarczyk has reached out to BP Intelligence, Security & Crisis Management to check

on rumored protests by the Walk the Line activist group in NW Indiana. Walk the Line has conducted peaceful protests in May of this year and September of 2017 by walking portions of a right-of-way for an Enbridge pipeline that feeds BP's Whiting Refinery. The group is opposed to the use of crude derived from Canadian oil sands.

Other Activities/News

- **Toledo** Abendhoff is working with the Toledo Blade and Toledo refinery manager Des Gillen to schedule an interview. The focus would be to introduce Des to the community, talk about his career and his thoughts about the refinery and the community.
- **Cleveland Airport** C&EA is supporting AirBP as it deals with the risk of a stockout situation this weekend at Cleveland Airport (CLE). Customers have been notified to tanker (bring in fuel from their origin airports and minimally uplift from CLE) and we hope this is sufficient to keep Cleveland supplied until a delayed pipeline delivery arrives and is certified. A holding statement has been prepared.
- **CA Power Bills** Power/utility issues are taking up much of the debate during the last weeks of the California legislative session. Moran is working closely with NAGP and WSPA on bills around wildfire liability, 100% renewable portfolio standard, and power technology procurement mandates. The 100% RPS bill is being worked hard by its author Kevin De Leon in his last days in the senate.
- **Dubuque Terminal** Rybarczyk continues to work with USPL and RM on community outreach following the stand down of the IMT for the Dubuque diesel release.
- **Toledo Stakeholder Event** Toledo Refinery, C&EA and Doug Sparkman hosted key local stakeholders at a private suite at a Toledo Mud Hens game. This was a great opportunity in a relaxed environment to enhance our relationship and show our appreciation for the support of our key stakeholders.
- **OH Electricity Rates** Ohio's four investor-owned utilities and state regulators continue to disagree whether the utilities are obligated to pass along the savings from the federal tax cut onto their ratepayers. The utilities oppose the Public Utilities Commission of Ohio proposal to lower rates calling it "retroactive rate-making." In its own recent filing, American Electric Power argues that the PUCO "is not permitted to unilaterally engage in single-issue ratemaking or change base rates without following the statutory process."
- **Bowling Green State University** Caprella met with BGSU on the upcoming STEM in the Park event sponsored by BP and held at the university. Along with having our logo recognized at the event attended by more than 3000 people, BP will have a hands-on activity booth for those in attendance. Caprella is working with the Toledo WIN BRG on this event. She has also joined the TWIN steering committee to support synergy and maximize other external engagements and sponsorships opportunities for BP.
- **Sump Sampling** Rybarczyk is working with USPL, Remediation Management, and BP Legal to share results of recent samples drawn from a residential sump pump with the homeowner in Tinley Park, Ill. The homeowner told BP he had detected oil in the sump pump, but testing showed no presence of any constituents associated with the nearby Chicap Pipe Line system.
- **Florida Constitutional Commission** Florida Attorney General Pam Bondi responded to a Florida Supreme Court filing by former Florida Supreme Court Justice Harry Lee Anstead requesting the Florida Department of State remove the bundled constitutional amendments from the ballot. Proposed Amendment 9 bundles a ban of drilling in state waters and restricting vaping in certain public areas. General Bondi argued in 47 pages that the Constitution does not preclude the Florida Constitutional Revision Commission from bundling amendments. In a separate effort, a group of former state legislators

have teamed with a public relations firm to initiate the "Save My Constitution" campaign urging voters to vote no on all the bundled CRC amendments and urging the Constitutional Revision Commission be removed from the Constitution.

- **Castrol** Moran discussed with Castrol reps, a workshop with CARB in October hosting the Detroit Advisory Panel – a group of autos and lube manufacturers. The workshop will discuss the potential impact of CARB regulation on lubes and is of interest to Castrol/Nexcel. Moran will attend for Castrol and is getting briefed by Nexcel next week.

- **Whiting Retirees** Keilman and Wortham met with leaders of the Standard Oil Annuitants Club to introduce Wortham and discuss the transition of responsibilities. The Annuitants requested that Wortham assist in identifying a member a BP speaker for their upcoming meeting.

- **Indianapolis Meetings** Keilman attended the Indiana Energy Consumers Association and IN State Senate Utility Committee Meeting. Keilman met separately with the next President of Senate Rod Bray. Keilman provided a refinery update and discussed 2019 legislative issues.

- **NW IN Labor** Keilman attended 2019 NW IN annual Building Trades summer event and provided one on one updates to State Senator Mrvan, State Rep. Soliday, and various union leadership.
