## **BP Wind & Alternative Energy**

**Maximize the value of the technology upgrade at Flatridge 1 by educating and bringing broader awareness to key stakeholders.**

No C&EA Update

**Influence AWEA to adopt industry-wide standards that improve operational safety by increasing participation on key committees and supporting BP Wind on panels at targeted conference.**

C&EA continues to finalize details of BP's participation at WINDPOWER, to be held in Houston May 20-23.

- BP/Castrol is the exclusive sponsor of the conference's opening reception, to be held May 20<sup>th</sup> at Discovery Green in Houston. BP will hold a private gathering during the reception where Al Vickers and Susan Dio will engage with AWEA leadership, local legislators and Houston stakeholders, and BP WE business partners.

- Brett Clanton is working with AWEA's public relations manager to determine if there is opportunity for a media interview(s) with Al either at the WINDPOWER Conference or at the BP WE office.

- AWEA will kickoff the Welcome Session with the BP Possibilities Everywhere video.

## **AWEA Update**

AWEA reported that on May 2 the U.S. Department of Energy (DOE) selected four projects for funding to develop next-generation wind turbine drivetrain technologies for tall land-based wind and offshore applications. The projects are aimed at developing more efficient, smaller, and lighter-weight generators. Each project will receive up to \$400,000 to design a generator that can be scaled up to at least 10 megawatts (MW). The selected projects are being led by General Electric, ABB Inc., WEG Energy, and American Superconductor Corporation. DOE will select one project to receive up to \$6.4 million to build and test a scaled prototype of their generator on a wind turbine.

**Build advocates to support BP wind farm sites with an expanded community presence and stronger stakeholder engagement.**

Viso is collaborating with site Performance Unit Managers to develop engagement outreach and activities during American Wind Week in August.

**Engage communities to build support for potential future AE developments and promote growth of the business.**

Penn State held a press conference where Rep. Chris Rabb and Senator Tom Killion introduced legislation to transition the state of Pennsylvania to 100% renewable energy by 2050 -- 50% by 2038, 80% by 2040 and 100% by 2050. During the press conference, Laurie Mazer, VP of Development, Lightsource BP highlighted the development of the largest development project (70 megawatts) in the state to support the university's strategic plan and confirmed Lightsource BP's commitment to support solar development in Pennsylvania and its goal to lower greenhouse emission goal.

Montreal based company, CDPQ, and Lightsource BP announced a partnership to finance a diversified portfolio composed of over 100 solar projects around the world totaling more than 700 MW.

Berkeley Pit – Mike Abendhoff responded to an inquiry from a reporter at the Montana Standard re completion of the polishing plant and testing of the pipeline from the plant to the creek. Abendhoff confirmed that construction activities are proceeding and expected to be complete in June; water will begin to be treated to the standard needed to release it to Silver Bow Creek and equipment and pipelines will be tested and approved by EPA before water is released. Copeland had garnered headlines in the run-up to the primary with comments about seeking more rigorous residential cleanup standards for areas impacted by the former USS Lead Superfund site.
