

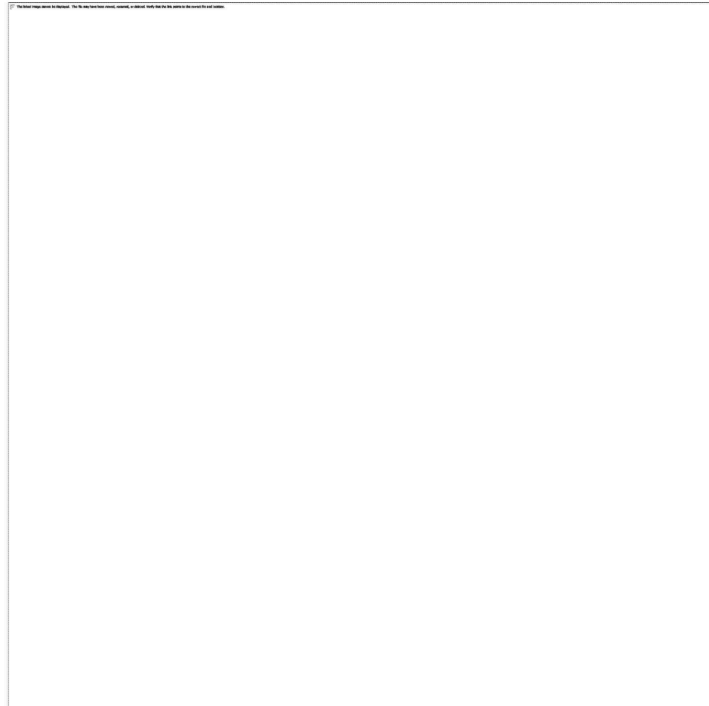

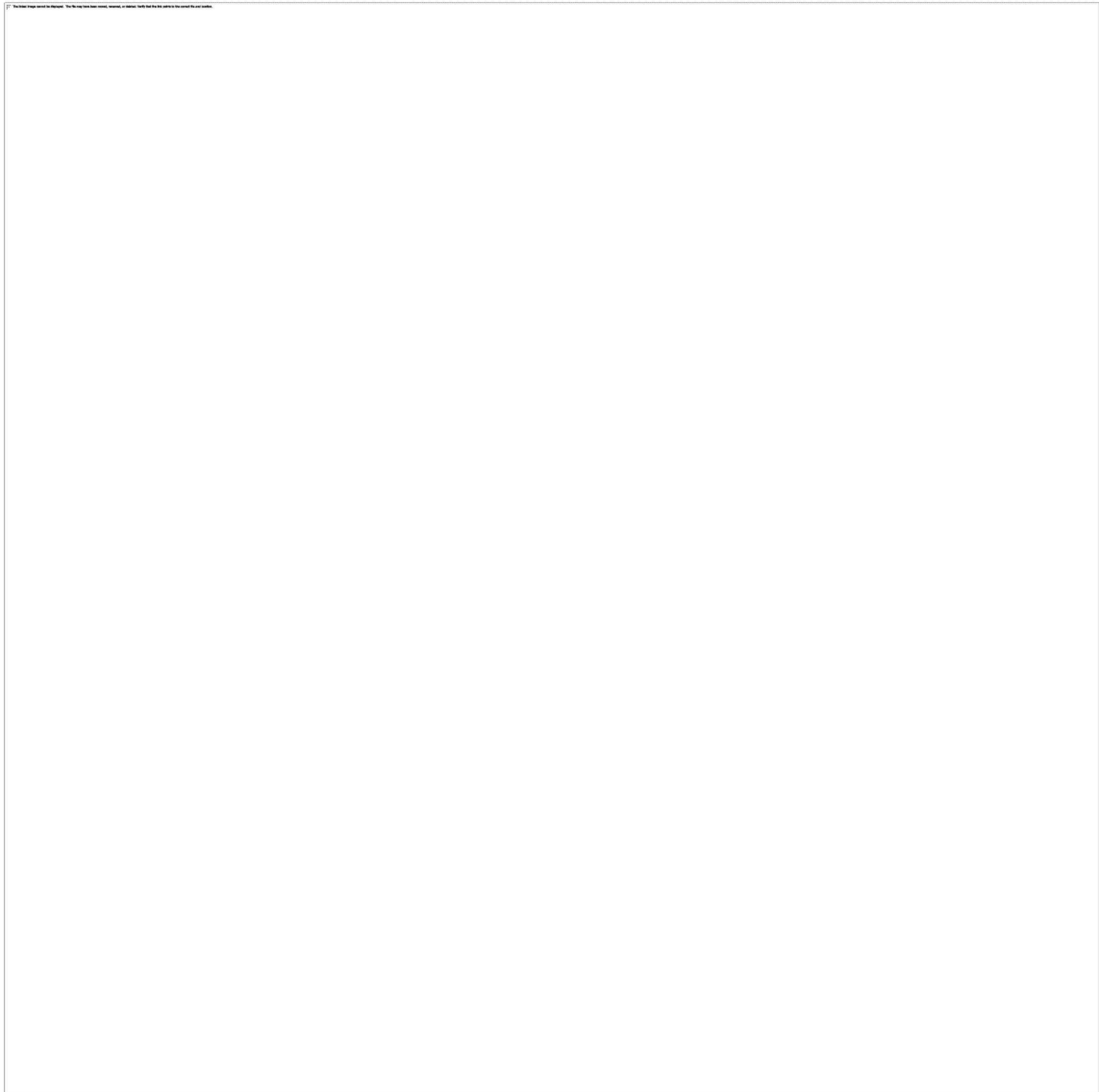

- An Energy Department-commissioned report from the University of Texas' Webber Energy Group submitted six months ago has been withheld by the Trump administration after it concluded that all energy resources have pros and cons for resilience and that the ability to store fuel on-site at coal and nuclear plants is only one of many factors in judging a plant's resilience, according to Michael Webber, head of the university group. Energy Secretary Rick Perry has said a governmental decision over whether to provide support to coal and nuclear power plants now sits with the White House. ([Bloomberg](#))
 - In an interview on CBS' "60 Minutes," President Donald Trump said that "something's changing and it'll change back again" regarding climate, adding, "I don't think it's a hoax." Trump also expressed hesitation to place "trillions and trillions of dollars" toward climate change and said he was unsure whether it is man-made. ([The Associated Press](#))
 - Interior Secretary Ryan Zinke's first meeting in office was held with Chris Cox, executive director of the National Rifle Association's advocacy group, followed the next day by a discussion with an official from Australian mining firm Sandfire Resources NL, according to new details on Zinke's calendar released to environmental group Western Values Project through a Freedom of Information Act request. The Interior Department pointed to its response from September from spokeswoman Heather Swift that the agency "will continue to be transparent in our scheduling process." ([CNN](#))

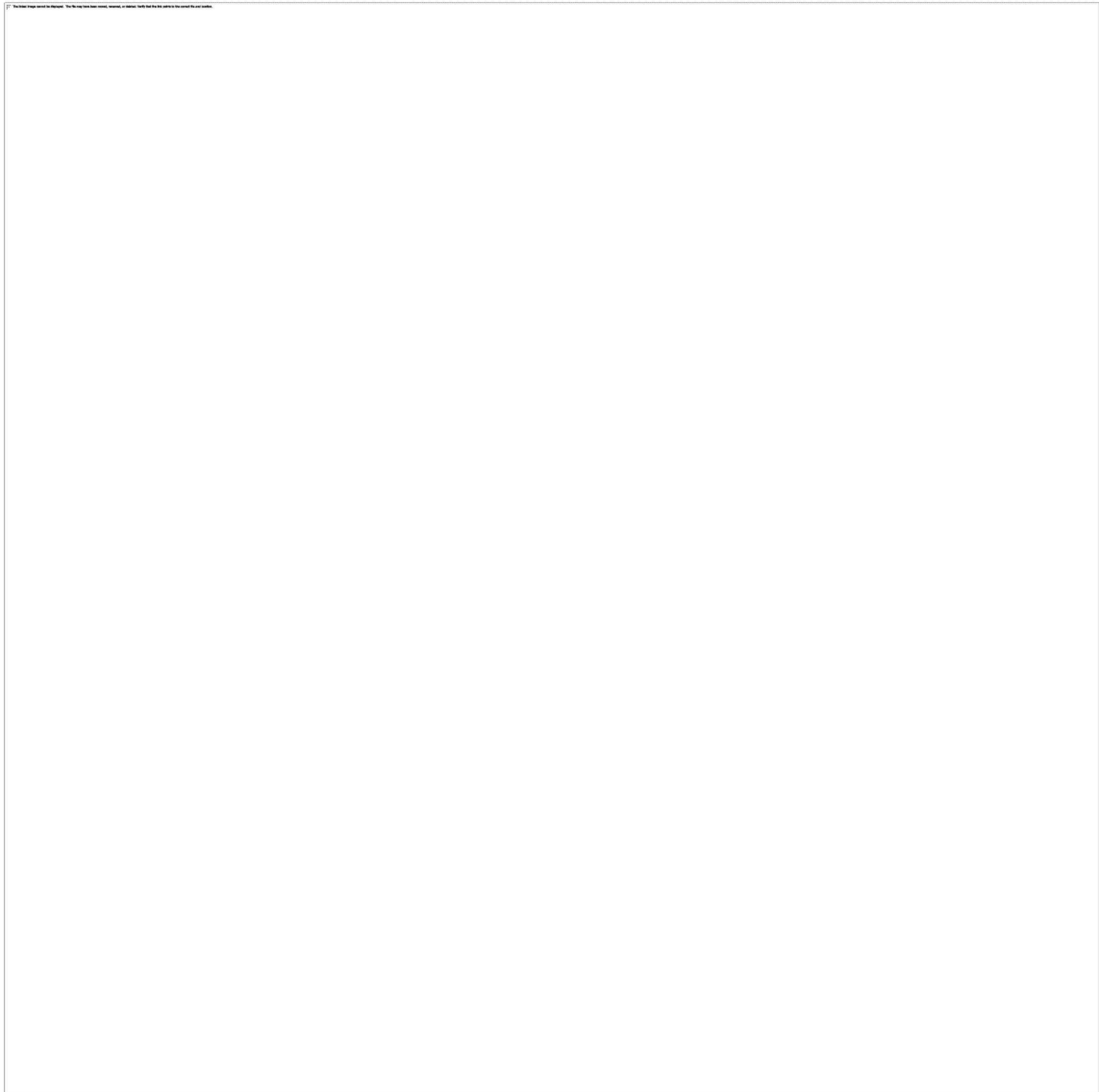
