KEY ITEMS, NEWS, AND EARLY FLAGS

⇒ The U.S. House of Representatives Natural Resources Committee passed two bills out of committee that would prohibit offshore oil and gas drilling. While likely to pass the full House along party lines, they are unlikely to be taken up by the Senate. (Please see “Congress” below)

- Industry News
 - W&T Offshore announced a discovery at its Gladden Deep prospect in GoM Mississippi Canyon block 800. The well is in approximately 3,000 ft of water and drilled to a total measured depth of 18,324 ft.
 - Total S.A. brought online its new Pangea III supercomputer, currently the most powerful commercial supercomputer of the world. Developed by IBP, the supercomputer will increase the company's computing capabilities by almost 5 to 31.7 petaflops (equivalent to 170,000 laptops combined) and triple the storage capacity to 76 petabytes. Total announced that this technology investment will allow the company to accelerate oil and gas exploration missions, crunching massive volumes of seismic data and utilize modeled seismic images to spot resource locations. They went on to say the technology will be used in “complex geologic environments wherein resources are trapped under salt, such as in Brazil, the Gulf of Mexico, Angola and the Eastern Mediterranean.”
- Weather
 - Disturbance #4 is barely identifiable now located south of Haiti over the Caribbean. Shear is very strong across this region and conditions remain unfavorable for any tropical development. No threat from this system.
 - Disturbance #5 is a weak tropical wave over the Atlantic still east of Trinidad. It is not showing any signs of organization, and tropical development is not expected. It should bring increased rain chances to Trinidad late tomorrow through Monday.

- Plaintiffs Sierra Club, Natural Resources Defense Council, Healthy Gulf, Center for Biological Diversity, Defenders of Wildlife, Friends of the Earth, North Carolina Coastal Federation, and South Carolina Coastal Conservation League have sued the Director of the Bureau of Safety and Environmental Enforcement (BSEE) claiming weaker standards could lead to another offshore incident. Claims include violations of the Administrative Procedures Act (APA), National Environmental Policy Act (NEPA), and the Outer Continental Shelf Lands Act (OCSLA).

- U.S. District Court Judge Martin Feldman granted a stay pending an appeal in a case of six defendants and coastal-permit lawsuits targeting Louisiana's energy industry and whether state or federal laws rule. Feldman's stay order, filed June 11, comes after he made an order to remand on May 28 in the case of The Parish of Plaquemines vs. River wood Production Co., Et Al. The case is one of 43 lawsuits aimed at more than 200 oil and gas companies that have been filed in state court by six Louisiana coastal parishes and the City of New Orleans.

CANADA

- Prime Minister Justin Trudeau announced cabinet approval of the Trans Mountain Expansion Project this week, with construction anticipated to begin this summer. As part of the announcement, the Prime Minister indicated every dollar earned from the project will be invested in Canada's "clean energy transition." This includes both revenues from operation of the project and any profits associated its eventual sale.

- Bill C-69, the Impact Assessment Act, continues to be progressed through the House with the objective of passing it before the end of this Parliamentary session but it will require approval by the Senate.
- The Senate amended Bill C-48, the Oil Tanker Moratorium, this week after it rejected a recommendation from the Senate Transport Committee to quash it.
