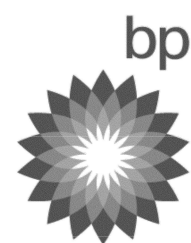

Appendices - peer report categorization of associations



Agreed principles (from previous steering group)

1. Basic information will be gathered for all associations (in and out of scope for full review) to support ongoing review process: Jurisdiction; SPA and positions held; fees; competition/anti-trust; overall focus and size.
2. Review should be rigorous, consistent and fair/objective.
3. Although assessment of associations will be undertaken against current BP policy positions, it is required to remain mindful of pace of change in the area.
4. Assessment will be undertaken using current and recent (two-years max) association positions, statements and information around policy input available in the public domain. Priority will be given to positions/ statements; guidance will be provided by BP on policy input focus areas and sources to avoid time wasting.
5. All sources must be referenced (i.e. using footnotes to enable checking and further investigation).
6. Silence will not be taken as positive or negative. With reference to overall context and to alignment of broader actions/ positions taken by the association this will be flagged as such.
7. Research will be undertaken by an independent third party – BSR.
8. Judgements on alignment will be made by BP.

Proposed assessment approach

Approach needs to be rigorous, consistent and fair/objective, and reference that stakeholders will have access to the same public sources (through footnoting). We should consider transparency of this process.

The following process seeks to address these points:

1. Briefing of BSR by BP – highlighting possible misalignments and information sources.
2. Information gathering by BSR, including assessment of each position as:
Likely aligned; Needs further review; No position.
3. Check of review findings by BP project manager and relationship holders as to whether information is complete, accurate and fair/objective.
4. BSR undertake any further information gathering required following review.

Proposed assessment approach - continued

5. Based on BSR report and with reference to guidance document, each position will be assessed by BP as: **Aligned; partially aligned; not aligned; no position;** or needs further review.
 - If required, BSR can be asked to seek further information at this point.
6. BP derive a recommended top-level status for each trade association as follows:
 - Take lowest rated of the top three positions – our key principles of Paris; science; rapid transition. No position is taken as partially aligned.
 - If there are more than two misalignments or no positions on subsequent five tactics then overall status is partially aligned. Unless already at that status or not aligned.

This should be taken as a guidance only and discussed with steering group and internal relationship holders. Worked examples follow.
7. Action agreed with reference to status but in broader context of value to BP of the association:
 - Not aligned means that action will be taken but does not dictate what action. This is guidance given by IIGCC principles.
 - Actions will be based on assessment of a variety of factors such as value to company, ability to influence or cost.
