RESOLUTION

Of inquiry requesting the President to transmit certain information to the House of Representatives referring to the termination, removal, placement on administrative leave, moved to another department of Federal employees and Inspectors General of agencies.

- 1 *Resolved*, That the President is requested to transmit,
- 2 to the extent that such documents are in the possession
- 3 of the President, to the House of Representatives, not
- 4 later than 14 days after the date of the adoption of this
- 5 resolution, in complete and unredacted form, a copy of the
- 6 following:

1 (1) Any and all documents and communica-
2 tions, including notes from meetings, audio records,
3 telephone and electronic mail records, text and other
4 digital messages, related to each Federal employee
5 placed on administrative leave, removed due to a re-
6 duction in force action, terminated, transferred, or
7 reassigned to another department on orders, advice,
8 or recommendation of Elon Musk, any individual
9 considered to be a member of a DOGE agency team,
10 or any official or unofficial member of the United
11 States DOGE Service since January 20, 2025.

12 (2) Any and all documents and communica-
13 tions, including notes from meetings, audio records,
14 telephone and electronic mail records, text and other
15 digital messages, related to the Office of Personnel
16 Management's determination that employees classi-
17 fied as Diversity, Equity, and Inclusion (commonly
18 referred to as "DEI"), Diversity, Equity, Inclusion,
19 and Accessibility (commonly referred to as
20 "DEIA"), or employed in a position in a DEIA of-
21 fice, would be deemed a competitive area subject to
22 a reduction in force notice, subject to the memo-
23 randum issued by the Office on January 24, 2025,
24 relating to "Guidance Regarding RIFs of DEIA Of-
25 fices".

1 (3) All documents or communications between
2 the Executive Office of the President, the Office of
3 Management and Budget, the Office of Personnel
4 Management, Elon Musk, any official or unofficial
5 member of the United States DOGE Service, any in-
6 dividual considered to be a member of a DOGE
7 agency team, or any other agency or Office of In-
8 spector General regarding the removal or termi-
9 nation of agency inspectors general, including wheth-
10 er to notify Congress as legally required.

11 (4) All documents and communications between
12 the Office of Management and Budget or the Office
13 of Personnel Management and Elon Musk, any
14 member, official, or non-official representative of the
15 Trump Campaign, Trump Transition Team, or
16 Trump Administration regarding the removal or ter-
17 mination of any Inspector General of an agency, in-
18 cluding whether to notify Congress as legally re-
19 quired.
