Dear Attorney General Garland:

We write to request information regarding whether the Department of Justice (DOJ) plans to resume federal executions and whether DOJ plans to procure pentobarbital sodium for use in federal executions.

On August 14, 2019, the Subcommittee on Civil Rights and Civil Liberties wrote to DOJ regarding the Trump Administration's decision to resume federal executions using pentobarbital sodium in a single-drug, lethal-injection protocol, a practice that had been halted pending a review ordered by the Obama Administration.¹ Before the federal single-drug protocol was adopted, there were multiple reports of states using pentobarbital in executions on inmates, causing them to scream of burning pain and writhe in agony while strapped to gurneys.² Despite these concerning reports, the Trump Administration used pentobarbital sourced from compounding pharmacies not regulated by the Food and Drug Administration (FDA) to conduct 13 executions between July 14, 2020, and January 16, 2021. These executions—carried out in less than one year—surpass the total number of federal executions conducted in the previous 70 years, between 1949 and 2019.³

On July 1, 2021, the Biden Administration issued a moratorium on all federal executions pending a review of the Trump Administration's federal death penalty policies and practices,

including its July 2019 Federal Execution Protocol Addendum.⁴ However, on October 13, 2021, DOJ urged the U.S. Supreme Court to reinstate the death penalty for Boston Marathon bomber Dzhokhar Tsarnaev, whose death sentence was overturned by an appeals court last year, raising new questions about its plans to resume federal executions.⁵

Given its recent actions, we are concerned that DOJ may renew its efforts to obtain pentobarbital from non-FDA-regulated pharmacies for use in future federal executions. This would be consistent with the actions of certain states that have continued using single-drug pentobarbital in state executions. For example, Texas has executed three inmates using pentobarbital since May 2021. The most recent use of pentobarbital in a state execution occurred in Missouri on October 5, 2021, when 61-year old Ernest Johnson was put to death.⁶ At least 14 states have adopted the single-drug pentobarbital execution protocol, though not all have used it.⁷

For these reasons, we request that you provide a staff briefing by December 22, 2021, regarding the status of DOJ's July 2021 review, including any findings; any plans to resume federal executions; any plans to procure pentobarbital for the purpose of conducting executions; and DOJ's policies, practices, or guidance on federal executions.

The Committee on Oversight and Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" and "any time" under House Rule X.
