Dear Chairman Comer:

I write to follow up on my request that the Committee's Republican Members join me and Committee Democrats in denouncing white nationalism and white supremacy, and the use of related conspiracy theories, including the "Great Replacement" theory, during Committee hearings and in all our work together.

As you may recall, during the Committee's February 7, 2023, hearing titled *On the Front Lines of the Border Crisis: A Hearing with Chief Patrol Agents*, several Committee Republicans invoked dangerous and conspiratorial rhetoric echoing the racist and nativist tropes peddled by white supremacists and right-wing extremists. In particular, some Members repeatedly described the number of migrants arriving at the border as an "invasion," and even went so far as to falsely accuse the Biden-Harris Administration of implementing a plan "to deliberately open our border" for purposes of "changing our culture"—mirroring language often used by MAGA extremists who believe that pro-immigration policies are designed to replace white populations with non-white immigrants and other racial minorities. As I explained to you at the hearing, such language borrows from the "Great Replacement" theory, the central dogma of contemporary white supremacy that has been repeatedly invoked by white nationalists to justify violent acts of domestic terrorism, including the mass murders of dozens of Americans at a Tops Supermarket in Buffalo, New York, the Tree of Life Synagogue in Pittsburgh, Pennsylvania, and a Walmart in El Paso, Texas.<sup>2</sup>

This is not the first time that you and other House Republicans have been called on to publicly renounce and denounce the racist and xenophobic tenets of white supremacy. On June 8, 2022, following the racially motivated Tops Supermarket mass shooting in Buffalo, New York, House Democrats passed H. Res. 1152, a resolution to condemn the "Great Replacement" theory and affirm the commitment of the People's House to combatting white supremacy and race hatred. Despite then-Minority Leader Kevin McCarthy's acknowledgment that white supremacy and white nationalism are "definitely not American," not a single House Republican voted in favor of the resolution.<sup>3</sup> In the words of the late Chairman Elijah Cummings, "we are better than this."

As Chairman, you have another opportunity to take a public stand against the deliberate amplification of dangerous racist rhetoric that has had deadly consequences in this country. That is why I am renewing my request for you and Committee Republicans to join Committee Democrats in speaking with one voice to forcefully and unequivocally denounce white nationalism and white supremacy, and the use of its central contemporary conspiracy theory, the "Great Replacement" theory. For your convenience, I am enclosing a draft statement for your consideration, which has been signed by every Democratic Member of this Committee.

If Committee Republicans intend to continue examining the southern border and related policies, it is imperative for *every* member of this Committee to make clear to the American people that we speak with one voice to reject dangerous conspiracy theories and racist and antisemitic ideology in our Committee's deliberations and decision-making. I feel certain—and I fervently hope—that you agree.

Thank you for your prompt attention to this important matter.
