"(e) Effect of Government Shutdown.—Cov-1 2 erage under a master contract under this chapter for longterm care insurance for an employee or member of the 3 4 uniformed services enrolled under such contract and who, 5 due to a lapse in appropriations, is furloughed or excepted from furlough and working without pay shall continue 6 during such lapse and may not be cancelled as a result 8 of nonpayment of premiums or other periodic charges due to such lapse.". 9 10 (b) REGULATIONS.—The Director of the Office of Personnel Management shall prescribe regulations under 12 which premiums for supplemental dental, supplemental vision, or long-term care insurance under chapter 89A, 89B, 13 or 90 (respectively) of title 5, United States Code, (as 14 15 amended by subsection (a)) that are unpaid by an employee or member of the uniformed services (as the case 16 17 may be), as a result of that employee or member being 18 furloughed or excepted from furlough and working without pay as a result of a lapse in appropriations, are paid to 19 the applicable carrier from back pay made available to the 20 21 employee or member as soon as practicable upon the end of such lapse. 22 23 (c) APPLICATION.—The amendments made by subsection (a) shall apply to any contract for supplemental
