A BILL

To amend chapter 22 of title 44, United States Code, to require certifications regarding certain Presidential and Vice Presidential Records, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Presidential Records
- 5 Certification Act of 2022".

1	SEC. 2. CERTIFICATIONS REGARDING CERTAIN PRESI-
2	DENTIAL AND VICE PRESIDENTIAL RECORDS.
3	(a) Amendment.—Chapter 22 of title 44, United
4	States Code, is amended by adding at the end the fol-
5	lowing:
6	"§ 2210. Certifications regarding certain Presidential
7	and Vice Presidential records
8	"(a) Certification.—On an annual basis, and with-
9	in 30 days after the applicable end date, the President,
10	Vice President, any individual acting as the President, and
11	each covered employee shall submit a written certification
12	to the Counsel to the President—
13	"(1) indicating compliance with this chapter
14	during the year prior to the submission of the cer-
15	tification; and
16	"(2) acknowledging that it is unlawful to know-
17	ingly and willingly falsify or fail to file any informa-
18	tion that such person is required to include in the
19	certification.
20	"(b) Submission.—The Counsel to the President
21	shall collect and maintain all certifications submitted to
22	the Counsel under subsection (a).
23	"(c) Failure to File or Filing False Re-
24	PORTS.—The Attorney General may bring a civil action
25	in any appropriate United States district court against an
26	individual who knowingly and willfully falsifies or who

1	knowingly and willfully fails to file or report any informa-
2	tion required pursuant to subsection (a). The court in
3	which such action is brought may assess against such indi-
4	vidual a civil penalty in any amount, not to exceed
5	\$50,000.
6	"(d) Definitions.—In this section:
7	"(1) COVERED EMPLOYEE.—The term 'covered
8	employee' has the meaning given that term in sec-
9	tion 2209.
10	"(2) End date.—The term 'end date' means—
11	"(A) with respect to the President or the
12	Vice President, the date on which the President
13	or the Vice President, respectively, is removed
14	from office, dies, resigns, or the then current
15	Presidential term expires;
16	"(B) with respect to an individual acting
17	as the President, the date on which such indi-
18	vidual may no longer discharge the powers and
19	duties of the office of President; and
20	"(C) with respect to a covered employee,
21	the date on which such individual ceases to be
22	a covered employee.
23	"(3) Individual acting as the presi-
24	DENT.—The term 'individual acting as the Presi-
25	dent' means an individual, other than the Vice

- 3 fice of President by reason of death, resignation, re-
- 4 moval from office, or inability.".
