#### Senior Leadership Briefing and Recovery Snapshots Hurricanes Maria, Irma, and Harvey Friday, October 13, 2017 (5:00 p.m. EDT) Updates in Blue

#### **Current Situation:**

Drier air will flow east and northeast through Puerto Rico and the U.S. Virgin Islands over the next 48 hours. A few scattered showers and thunderstorms capable of heavy rainfall, cloud to ground lightning, and flash flooding are expected, especially in the afternoon hours.

A Flash Flood Warning remains in effect for areas near the Guajataca Dam and flood advisories have been issued for southwest Puerto Rico. Rainfall amounts greater than two



inches are expected in some small mountainous areas in southwest Puerto Rico; lighter, more isolated rainfall is expected in most areas. River and small stream flooding, mudslides, and rock falls are still possible, as soils are already saturated and loose, and many rivers and small streams are running at above normal levels. Heavy rain is expected in Puerto Rico and the U.S. Virgin Islands late Sunday into early Tuesday. (NOAA Update, October 13, 2017, 5:00 p.m. EDT)
