#### **TODAY AT 12:15 pm EDT: API to Hold Media Call to Discuss Industry Action and Policies on Climate Change**

WASHINGTON, March 25, 2021 – Ahead of President Biden's first press conference, the American Petroleum Institute (API) will hold a media call at 12:15 PM EDT today to discuss how the natural gas and oil industry is working to address the risks of climate change and engaging the new administration to drive further progress on emissions reductions. Earlier this week, API President and CEO Mike Sommers met virtually with National Climate Advisor Gina McCarthy alongside other industry leaders to discuss how we can achieve our shared goal of a low-carbon future while sustaining American energy leadership.
