## PROFESSIONAL DEVELOPMENT:

- Building off Dave's recent email, the latest issue of <u>Harvard Business Review</u> outlines 'how to ask a colleague to mask up.' Here are three suggestions for how to make the request more effective:
- 1. **Be prepared**. If you know what you are going to say in advance instead of having to come up with something on the spot it's a lot easier to follow through.
- 2. **Ask in a way that allows the other person to save face.** That is, you want to affirm that you don't think the other person is a bad person, and that you aren't rejecting them interpersonally. In essence, your script should convey, "You're good. We're good. But I just need you to do this thing."
- 3. **Be direct**. A direct request, in contrast to indirect beating around the bush, is much more effective for securing someone's compliance.
- Ted Lasso is more than a 'bright spot in a painful world'; <u>Fast Company looks at 5</u> times the show exemplified what great leadership looks like. Two that stand out: "believe" and "kindness matters". Now go "be a goldfish."
