Rachel Woods/Carbon policy advocacy campaign: A number of us participated in the carbon policy advocacy campaign kick-off call Rachel Woods held. **Bottom line up front: This will have limited relevancy to us in the U.S.**

- BP is going to create a UK-focused carbon price campaign. Basically, their objective is to create something like a CEO Climate Roundtable, but have a lengthy process in mind that includes policy papers, Value at Stake, economic impact review for BP businesses, etc.. They are looking for U.S. C&EA to provide "lessons learned" advice from our carbon price campaign efforts. Similarly, they are asking the European team to engage for alignment purposes. They are not looking to get involved in our campaign efforts – at least for now. I will join a periodic call Rachel will hold on carbon pricing strategy and Phil and Jim Nolan will join a periodic policy call to offer insight and ensure alignment. Neither should be a significant time commitment.

Budget cuts at RM impacting priorities: RM's operating budget has been cut by one-third. They are reprioritizing work at project sites and that will mean that C&A will focus on a smaller number of project sites. This could have implications for the upcoming C&A organizational redesign.

- **One significant addition:** a former mine site in Rico, Colorado has been elevated to a purple risk related to the potential for a mine plug failure similar to the Golden King mine disaster from several years ago. RM has done good work to mitigate the risk but the company has elevated it because of the worst-case scenario potential.

The return of PTAir: Petchem is near receiving certification of PTAir as a low-carbon alternative for PTA with rollout likely in August.

- Alistair Shaw from the UK Petchem communications team reached out about a roll-out campaign for the product. On our second call today, I weighed in to make certain that our team would take the lead in building the roll-out strategy rather than having it led from London. We, of course, will work collaboratively with Alistair and utilize many of the products already created when PTAir rolled out in Europe. JP assigned Sarah Howell to lead from the Comms side and Iris, Suzanne and Hope will work on a stakeholder engagement strategy. The team is well-connected to the business in this effort.

Our Energy Policy TCI webinar: BP is sponsoring a June 10th webinar by Our Energy Policy on TCI. The group successfully landed

- Bob also will serve as a panelist on a RGGI webinar the following week.
