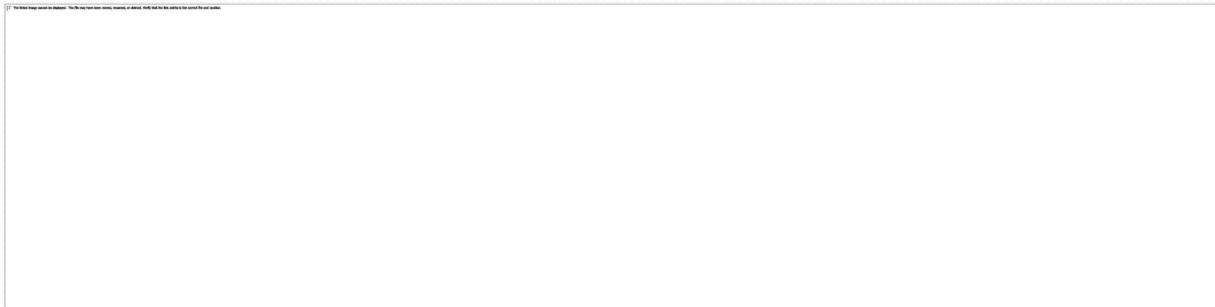

Dear colleagues,

I hope you are all staying well and healthy. I have not had the chance to meet most of you in person yet, but I look forward to doing that once it is safe. I know it's been an incredibly challenging last few months – and in many ways a strange time to join bp. But I am so proud to be a member of such a fantastic team, who are delivering such incredible work in trying circumstances.

In February this year bp adopted a new purpose – **reimagining energy for people and our planet**. Throughout the COVID-19 crisis bp people have been putting that purpose into action, stepping up to help their communities. This has only underlined the importance of putting purpose at the core of everything we do as a company and to think about the actions we can take to help our planet and improve people's lives. To that end, I wanted to share with you some exciting new developments for our broader sustainability agenda.

1. We're launching a new biodiversity position

The rich biodiversity of our planet is under threat. There is increasing international concern about the global decline in biodiversity and the potential impacts on human welfare. Transformative change is needed and we recognise the intrinsic link between the need for global action on biodiversity and climate change. So we are taking action to restore, maintain and enhance nature, through a new position on biodiversity, in which:

- We commit not to operate any new oil and gas exploration or production activities inside the boundary of officially inscribed UNESCO World Heritage sites, or inside the boundary of Strict Nature Reserves (IUCN Ia) or Wilderness Areas (IUCN Ib) as listed by IUCN on 1 January 2020.
- We will aim to achieve a net positive impact on biodiversity in our new projects.
- We will aim to enhance biodiversity around our existing major operating sites.
- We will aim to support biodiversity restoration and the sustainable use of natural resources in countries where we have existing and growing investments.

The biodiversity position launch will happen externally on **5 June**, to coincide with World Environment Day.

2. We've updated our human rights policy

Since we published our original human rights policy seven years ago the world has moved on significantly. To reflect the role we want to play in respecting and protecting people, we have updated our policy to include:

- More explicit commitments to respecting the human rights of vulnerable groups;
- A new statement on the value we attach to open societies, respect for civic freedoms and the rule of law, recognizing the important role that human rights defenders can play in the countries where we operate;
- More detail on our approach to respecting human rights in some important areas: water and sanitation, indigenous peoples' rights, land rights, freedom of speech and worker rights, through our [Labour Rights and Modern Slavery Principles](#).

The human rights policy is applicable to all employees and bp operated activities, and a new governance process for our human rights defenders statement will be communicated from 1 June. We are **all** accountable for delivering our commitments on human rights, from the board-level to the local level.

The human rights policy will be formally launched the week of **11 June** and available from today on [bp.com](https://www.bp.com).

You have an important role in implementing and cascading the position and policy. Please familiarise yourself with the content and take the necessary action to conform with them.
