I hope all is well with you. I wanted to invite you to a workshop later this month. BP is, through OGCI, leading a project to develop CCS enabling narratives and identify blockers and enablers. We have done a first phase in Europe and Canada with great success, and are now focusing on the US. (The attached document describes the project in more detail).

As part of this we're having a workshop in Washington DC on Oct 28/29 (working dinner on 28th, workshop all day 29<sup>th</sup>). I know it is short notice, but would you be able to attend?
