All, the more we have discussed this internally, the more we are wondering if it's prudent to create a standalone news story around this item as CLC is proposing. It feels like we will give it undue attention if we do that.

We are thinking it makes more sense for them to announce it when they release the blueprint along with the language they've been developing ("... it's an important issue... think Congress will do something about it... but not part of the blueprint ... etc.'). That way there will be other news to go along with it so it's a small (albeit important) part of a bigger news event.

I spoke with Ted today. He asked how much time we need to reach a decision – I told him "we will not need more time than ExxonMobil requires, so whatever time EM requires we will work within that schedule."

Ted's HPS consultants made a compelling case for two communications items:

Getting the information about the liability limitation into the press during the August 'lull' via Axios.
 Not combining the communication about the liability limitation with the overall release of the Roadmap in October.

I pressed him on the perception that Microsoft is setting our decision deadline and how difficult that is to explain to management. He claimed that it is 'more than just Microsoft'. When I suggested we speak with Microsoft directly, he offered to arrange that conversation.

Nick: Ted said he's speaking with you tomorrow and requested my opinion or intel about EM decision and intention to stay or leave CLC, which I refused to answer. I did reiterate that we would require no more time to make a decision than EM would require.
