A Transmission Renaissance in the West

Some have observed that in the West, we are better at transmission *planning* than actually building it. A good part of the western transmission grid was built in the 1970s and 1980s, and not with renewable energy considerations that are now at the heart of the cleantech revolution in the region. However, that is rapidly changing, spurred by the passage of several clean energy law and the retirement of older generation facilities. There is a need for over 90 GW of new wind and solar investments in the next decade. Utilities and transmission developers are responding with significant investments that will stake what's planned to the construction of new transmission, including Utah-Wyoming, Colorado, New Mexico-California and Nevada. This panel will discuss what's changed and the continued importance of investing in new and upgraded transmission infrastructure to achieve significant consumer-savings, economic investment and GhG reduction benefit.
