**COURTOVICH FIRM SIGNS NEW LOBBYING CLIENT:** SGR LLC **Government Relations and Lobbying**, the sister firm to **Jim Courtovich's Sphere Consulting**, has reported signing its first lobbying client since **The Wall Street Journal** [revealed last month](#) that federal authorities are looking into whether Courtovich was involved in a kickback scheme. SGR's **James Graham Miller** will lobby for **A & C Laboratories**, a biotech firm, on "Issues related to the Controlled Substance Act and medical research,"

according to a disclosure report. SGR actually signed the client in December but didn't file the paperwork reporting it until last week. The Journal's **Brody Mullins** has reported that the FBI and the Justice Department are looking into whether Courtovich or his former firm, National Media, helped **Evan Morris**, a former **Genentech** lobbyist, hide payments as part of a kickback scheme. Courtovich's lawyer, **Eric Lewis**, said in a statement at the time that "any assertion that Sphere is the target of a government investigation is unfounded."

**PRO-TRUMP NONPROFIT PLAGUED BY POWER STRUGGLES:** "A political group launched by some of President **Donald Trump**'s top campaign advisers to boost the White House in its biggest policy fights has been conspicuously absent as Trump begins to sell his agenda, hobbled by staffing delays, internal jockeying for control and a struggle to win the favor of big donors," **POLITICO**'s **Shane Goldmacher** reports. "Trump counselor **Kellyanne Conway** once promised the organization, now known as **America First Policies**, would provide a "surround-sound super structure" to boost the president's goals. After nearly two months, there has been little activity aside from a press release announcing the group's formation and a recent smattering of posts on Twitter and Facebook."

- "'To say that the folks inside the White House are disappointed that there's been no air support in the first 50 days is an understatement,' said a person involved with the nonprofit, one of [10] Trump officials engaged with the group or at the White House who spoke about the group with **POLITICO**. 'Things have moved very slow and there's a lot of frustration that things need to move faster.' Now some are setting out to create a second competing nonprofit group, with the notable backing of the wealthy Mercer family, who are perhaps the most prominent donors in Trump's orbit and who have long sought strict authority over their political spending. A third group could even be in the works." Full story.

**KUSHNER FAMILY COMPANY SET TO STRIKE DEAL WITH CHINESE:** "A company owned by the family of **Jared Kushner**, President **Donald Trump**'s son-in-law and senior adviser, stands to receive more than \$400 million from a prominent Chinese company that is investing in the Kushners' marquee Manhattan office tower at 666 Fifth Ave," **Bloomberg News'** **David Kocieniewski** and **Caleb Melby** report. "The planned \$4-billion transaction includes terms that some real estate experts consider unusually favorable for the Kushners. It provides them with both a sizable cash payout from **Anbang Insurance Group** for a property that has struggled financially and an equity stake in a new partnership. ... It would make business partners of **Kushner Cos.** and Anbang, whose murky links to the Chinese power structure have raised national security concerns over its U.S. investments." Full story.

**HOUSE DEMOCRATS HOST OSSOFF FUNDRAISER:** The top House Democratic brass will host a fundraiser on Thursday at Democratic National Committee headquarters for **Jon Ossoff**, whom Democrats have seized on as their best shot at snapping up the conservative-leaning House seat in the Atlanta suburbs vacated by HHS Secretary **Tom Price**. Among the headliners: House Minority Leader **Nancy Pelosi**; Minority Whip **Steny Hoyer**; Assistant Minority Leader **Jim Clyburn**; Caucus Chairman **Joe Crowley**;

Caucus Vice Chairwoman [Linda Sánchez](#); DCCC Chairman [Ben Ray Lujan](#); and Reps. [Sanford Bishop](#), [Hank Johnson](#), [John Lewis](#) and [David Scott](#), all Georgia Democrats. The jungle primary for the special election is April 18. **[Here's the invitation](#)**.

**ACLU LAUNCHES GRASSROOTS EFFORT:** "The ACLU is spending millions of dollars on a plunge into grassroots politics - a 'People Power' campaign," **The Washington Post's David Weigel** reports. "It's the newest and largest development from a sprawling 'resistance' movement that regularly moves faster than the Democratic Party's leaders can think and isn't waiting on politicians for cues. People Power debuted this weekend in South Florida and, by the organization's estimate, at thousands of weekend house parties nationwide. Everyone who showed up received a nine-point plan to turn blue America into a network of 'freedom cities' by defying the president's executive orders, his health-care agenda and his Justice Department." **[Full story](#)**.

**LAWYERS PLAN TO HOUND TRUMP USING FOIA:** "Concerned by the shortage of government experience and early missteps by Trump administration officials - including President Trump - a group of lawyers is launching a watchdog organization that will seek to track the administration's ethics and expose potential conflicts, fraud or other wrongdoing," **USA Today's Donovan Slack** reports. The organization, 'American Oversight,' which says it is nonpartisan despite some of its founders having deep ties to Democrats, will focus on prying loose documents through public records requests and lawsuits under the Freedom of Information Act." **[Full story](#)**.

**DAIRY LOBBY HEADS TO MEXICO:** "Top U.S. dairy industry officials are headed to Mexico next week on a mission to save their top export market as European Union and New Zealand competitors look for ways to exploit the uncertainties created by President **Donald Trump**'s push to renegotiate NAFTA," **POLITICO's Doug Palmer** reports. "We want to reemphasize the fact that Mexico is a valued customer for dairy," said [former Agriculture Secretary] **Tom Vilsack**, president and CEO of the **U.S. Dairy Export Council**. "Obviously any agreement that's been around for awhile has areas where there can be improvements, but we want to make sure they understand, from our perspective, that preserving NAFTA is important." **[Full story](#)**.

**HOUSE WEIGHS FEC OVERSIGHT HEARING:** "The Federal Election Commission - an agency of clashing commissioners, seething staffers and key vacancies - may soon face congressmen who wonder: Why's the agency a basket case?" the **Center for Public Integrity's Dave Levinthal** reports. "Such a trip under Congress' microscope could come in the form of a Committee on House Administration oversight hearing, something the FEC hasn't endured since 2011, when super PACs were still novel and the now-seminal *Citizens United v. FEC* decision wasn't yet two years old. A planned oversight hearing in 2014 [never materialized](#). 'It's time,' Committee on House Administration member **Barry Loudermilk**, a Republican congressman from Georgia, told the Center for Public Integrity. 'We should take the opportunity and have a re-evaluation.'" **[Full story](#)**.

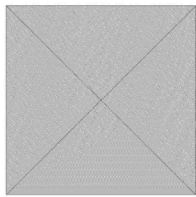
