Hi Jason,

Ben Storrow from E&E News. I'm working on a story today that is a follow up to the news from last week that BP supports federal methane regulations. Story is looking at the majors record on methane, and asking whether this provides a significant boost to efforts to limit emissions.

Questions:

- BP has said it supports federal methane regulations. That begs the question, what type of regulations does it support?
- Does it support semiannual LDAR inspections, as proposed under the Obama administration? Or does it support annual inspections as proposed by the Trump administration?
- What is its opinion on low production wells? Should they be subject to methane regulations, or given an exemption?
- To date, most federal efforts have focused on production. Would BP support methane regulations for shipping, processing and refining?
- The FT and others have raised concerns about BP's past opposition to federal methane regulations. A couple questions on that subject.
- The industry position in prior years, broadly speaking, was that companies were already taking action to reduce methane production and that voluntary efforts on the part of industry was enough to address the issue. What changed?
- What would the company say to those worried this announcement represents greenwashing and not a real commitment to reducing emissions?
