TJ – I've been involved in two or three separate discussions over the past couple of weeks about how we need to do a better job of communicating what we think a low carbon future might look like. Not just what we outline in the ECS, but more tied to what we are working on and how it fits together. I think we could take a simplified version of Vijay's package that illustrated how gas conversion fits with fuel cell CCS, hydrogen, etc and begin to use that material to move beyond just talking about algae biofuels and CCS. I'm not sure if anyone is working on that, it doesn't sound like it from the discussions I have had. I think between EMRE, CSP and P&GA we could pull together a good communications package that we can use going forward. In my view, we should start pulling that together now instead of waiting until we want something for the Investor Day presentations. I also think it will help address some of the points that Gerry has raised as part of the climate work. I would propose we set up a small team to take that material and develop some options – what do you think?
