Dear Chairwoman Svinicki:

We are writing to request documents related to federal funds expended by your Department – including all agencies within the Department – on products or services provided by businesses owned by or affiliated with the Trump Organization.

The American people deserve to know how their tax dollars are spent, including the amount of federal funds that are being provided to private businesses owned by the President and the purposes of these expenditures.

Against the advice of ethics experts from both parties, President Trump has chosen to break with modern precedent and become the first President in four decades not to liquidate his assets and place them in a truly blind and diversified trust.<sup>1</sup> Instead, President Trump has placed his assets in a revocable trust from which he can withdraw any amount of money he wants whenever he chooses to do so.<sup>2</sup>

The President's financial entanglements make it impossible to know whether he is making his decisions in the public interest or to benefit to him or his family members financially. The President's continued ownership of private businesses also places federal employees in compromised positions when they work on official activities that potentially create financial benefits for the President or his family members.

For example, the *Washington Post* recently reported that the Department of State “spent more than \$15,000 to book 19 rooms at the new Trump hotel in Vancouver when members of

President Trump's family headlined the grand opening of the tower in late February." According to the article, "A State Department official did not answer questions about who stayed at the Trump hotel and the reasons for their stay."<sup>3</sup>

This follows reports that the State Department previously spent "\$9,510 for hotel rooms to assist the Secret Service" in conjunction with "Eric Trump's business trip to Uruguay in early January to promote a Trump hotel and condominium tower."<sup>4</sup>

It also appears that federal funds have flowed to Trump family businesses via other channels. For instance, the *Washington Post* has reported that the Department of Defense is renting space at Trump Tower.<sup>5</sup>

President Trump is also receiving federal housing assistance payments as a result of his 4% ownership interest in Starrett City Associates, L.P.<sup>6</sup> Starrett City is the nation's largest federally subsidized residential property.<sup>7</sup> Under a housing assistance payment contract with the Department of Housing and Urban Development, 3,569 units in the complex receive federal housing assistance.<sup>8</sup> According to the *Washington Post*, Starrett City's owners have received "more than \$490 million in rent subsidies since May 2013."<sup>9</sup>

President Trump also makes frequent trips to properties he owns, and these trips may result in U.S. taxpayers' money flowing into President Trump's pockets. For example, by April 2017, President Trump reportedly had made seven trips totaling 25 days to his private club in

Florida, Mar-a-Lago.<sup>10</sup> *Politico* estimated that each of these trips may have incurred as much as \$3 million in federal costs.<sup>11</sup>

President Trump also has made several trips to his property in New Jersey, the Trump National Golf Club-Bedminster, claiming in tweets that staying there “saves country money” and that “staying in NYC is much more expensive.”<sup>12</sup>

However, the Trump Administration has not disclosed the total amount of federal expenditures associated with the President’s trips to Mar-a-Lago, Bedminster—or any properties he owns—and it has not disclosed whether expenditures by the federal government were paid to the President’s properties or whether the President benefited financially from these expenditures.

There may be other expenditures of American taxpayer funds at Trump properties that are not yet publicly known. Federal agencies and their employees may be hosting events or renting hotel rooms at Trump properties, eating meals at Trump property restaurants, or contracting for equipment rentals with Trump businesses.

### **Request for Documents**

In order to identify the total amount of taxpayer funds being expended by the U.S. government to businesses owned by or affiliated with President Trump, please provide the following documents by August 25, 2017:

1. all documents relating to or regarding any expenditure made by any entity within your department to the Trump Organization or the President’s trust;
2. all documents relating to or regarding any expenditure made by any entity within your department to any business in which the Trump Organization has an ownership stake;
3. all documents relating to or regarding any expenditure made by any entity within your department to any business with which the Trump Organization has any licensing agreement or similar contractual relationship, including any business that bears the name “Trump” in its title; and
4. all documents relating to or regarding any expenditure made by any entity within your department in conjunction with any travel undertaken by any member of the Trump family to promote a business in which the Trump Organization has any ownership stake, licensing agreement, or similar contractual arrangement.


