Dear Mr. McGahn:

On October 4, 2017, four U.S. service members died and two more were severely injured during an operation in Niger.<sup>1</sup> These are the first combat-related American deaths in the course of the U.S. Special Forces training and assistance to the Nigerien armed forces.<sup>2</sup> Nearly three weeks after the attack, many questions remain regarding the purpose of the operation, the circumstances surrounding the ambush, and the military response to the tragedy.

The Committee has a history of investigating certain deaths of U.S. servicemen killed in the line of duty, in addition to the Committee on Armed Services and the Permanent Select Committee on Intelligence.<sup>3</sup> The Committee plays a unique role in conducting interagency oversight in the House, and has jurisdiction over management of government operations generally and intergovernmental affairs.

I request that you provide a briefing regarding the Niger attack to all Committee Members as soon as possible. Please allow ample time for questions from Members during this briefing. I am sending similar requests to the Department of Defense and the Office of the Director of National Intelligence.
