Dear Acting Secretary McAleenan:

I am writing to reiterate in the strongest terms the Committee's request for your voluntary testimony on July 12, 2019, to address the Trump Administration's separation and treatment of immigrant children at the southern border. The Committee first requested your appearance on June 28, 2019.¹ Yesterday, your staff sent a letter requesting a separate panel at the hearing, but suggesting that you may not be able to "accommodate" the July 12 date.²

To address your staff's request on panel structure, the Committee will allow you and Acting Customs and Border Protection Commissioner Mark Morgan to testify on your own panel for this hearing. However, over the past several weeks, there have been a number of troubling revelations, including:

- Reports of unaccompanied children in overcrowded and filthy conditions at Clint, Texas, and other facilities³;
- Racist, sexist, and xenophobic posts by Border Patrol employees⁴; and

> • A report issued just this morning by the Department of Homeland Security Inspector General on "dangerous overcrowding" and "prolonged detention of children."⁵

In light of these disturbing developments, the Committee will not postpone its hearing on these matters until a later date. As Acting Secretary, you lead the agency responsible for these actions and these conditions, and your testimony is critical to the Committee's review.
