Dear Chairman Chaffetz and Ranking Member Cummings:

I write to thank you for your past oversight of price increases within the prescription drug market, and to request a congressional hearing examining the availability and pricing of EpiPens.

According to yesterday's Forbes.com article "Why Did Mylan Hike EpiPen Prices 400%? Because They Could" Mylan acquired the EpiPen autoinjector in 2007, at which time EpiPens cost about \$57. Today, they can cost more than \$500. The availability and affordability of this product could literally mean the difference between life and death for thousands of Americans. Unfortunately, I fear this dramatic increase in price over such a short period of time could have tragic consequences.

According to recent reports, an EpiPen injects less than a dollar's worth of the life-saving drug epinephrine into a person suffering from anaphylaxis (a severe allergic reaction that may result in death). It is unclear to me what warrants such a dramatic mark-up in price, and it is my hope that a hearing before your committee will answer that question. As a mother, and as a Co-Chair of the Bipartisan Congressional Kids' Safety Caucus, I believe Americans have a right to know why access to this inexpensive-to-produce device has been so severely constrained.
