I write to follow up on the Committee's May 1, 2025, letter seeking information relevant to Elon Musk's background, including his reported history of drug use, and again request that you produce documents and information detailing whether he has fully disclosed all necessary information to the United States.<sup>1</sup> The White House has failed to respond to this request, which has only grown more pertinent as recent reporting indicates that Mr. Musk consumed extensive amounts of illicit and prescription drugs that "went well beyond occasional use" while on the 2024 presidential campaign trail with Donald Trump.<sup>2</sup>

The American people deserve to know the history and extent of Mr. Musk's drug use, whether he continued his drug use while a special government employee and senior adviser to President Donald Trump, and any influence illicit drugs may have had on his actions and decisions as a special government employee. Moreover, it is critical to determine whether Mr. Musk has fully disclosed his prior drug use to the United States, including on his Form SF-86, and whether Musk has been truthful in all aspects of his disclosures.

Accordingly, I reiterate and renew the request for documents, materials, and information contained in the Committee's May 1, 2025, letter and demand that you produce this information to the Committee by Friday, June 13, 2025.<sup>3</sup>




