I write regarding Fox News' deceptive editing of an interview with President Trump regarding the criminal investigation into his longtime friend, convicted sex offender, and child sex trafficker Jeffrey Epstein. On June 2, 2024, in the midst of his presidential campaign, Fox & Friends aired an interview with President Trump in which he was asked whether he would declassify files related to Jeffrey Epstein. President Trump appears to respond, "Yeah. Yeah, I would."<sup>1</sup> However, in the raw footage, President Trump clearly refuses to unequivocally endorse full declassification of the Epstein files. Trump says, "You don't want to affect people's lives if it's phony stuff in there."<sup>2</sup> Trump's true answer was only released later, after the hype of the initial Sunday broadcast had reached the most people, as the Trump campaign continued to amplify the manipulated—and clearly manipulative—version.<sup>3</sup> In light of recent allegations by President Trump's former confidant, Elon Musk, that the Epstein files are being withheld because they implicate the President, as well as recent attempts by the Department of Justice, the Federal Bureau of Investigation (FBI), and President Trump himself to shut down public interest in Epstein's clients, I request information to determine whether the President or any member of his campaign may have interfered with your company's decision to edit this interview and mislead the American people in its premier broadcast.<sup>4</sup>

Recently, President Trump has demanded that the American people "not waste Time and Energy on Jeffrey Epstein."<sup>5</sup> This is a dramatic reversal by the President and many current Trump Administration officials, who previously attempted to win credibility with the public by claiming that Jeffrey Epstein's "client list" should be released.<sup>6</sup> Indeed, President Trump's campaign actively amplified his misleading, edited answer, claiming that he had promised full declassification.<sup>7</sup> Prior to becoming FBI director, Kash Patel suggested that the FBI was hiding a list of Jeffrey Epstein's clients "because of who's on that list."<sup>8</sup> In 2024, while campaigning to become vice president, JD Vance said, "We need to release the Epstein list."<sup>9</sup> In February 2025, Attorney General Pam Bondi assured Americans that a so-called Epstein client list does not even exist.<sup>11</sup> And in an emotionally volatile and defensive social media post, President Trump called his own supporters "stupid," "foolish," and "weaklings" for continuing to ask questions about the Epstein client list, openly asserting that he does "not want their support anymore!" and bizarrely accusing Democrats of perpetrating a hoax.<sup>12</sup> It is obvious to the American public that someone is lying and someone is trying to hide something.

As a network that reaches an estimated 2,663,000 total viewers, Fox News should not be in the business of censoring interviews with presidential candidates to mislead the public.<sup>13</sup> The American people have a right to understand why *Fox & Friends* chose to alter President Trump's

stated position on the release of the Epstein files. Considering President Trump's welldocumented past social ties with Jeffrey Epstein, Fox News's selective omission raises serious concerns that the network may have deliberately sought to shield then-candidate Trump from any further association with Epstein or the horrific crimes he perpetrated for decades—grooming, abusing, and trafficking minors for sex.<sup>14</sup>

It is legitimate to ask whether President Trump himself or those close to him may have actively encouraged this withholding of information from the American people. On June 5, 2025, Elon Musk, the former senior advisor to the President and head of the Department of Government Efficiency, posted on X: "@realDonaldTrump is in the Epstein files. That is the real reason they have not been made public."<sup>15</sup> Last month, I formally requested that Attorney General Bondi and Director Patel clarify whether this allegation is true and provide basic information about the President's role in withholding documents from declassification.<sup>16</sup>

This question is more pressing given President Trump's efforts to punish Paramount Global, a media outlet, for airing two different clips of an interview with a political opponent. President Trump sued CBS News for editing an interview with former Vice President Kamala Harris and presenting what he claimed were "doctored" versions to Americans, despite the clips depicting two parts of the same answer that did not substantially change its meaning.<sup>17</sup> In an October 31, 2024, complaint, attorneys for then-candidate Trump wrote that "millions of Americans … were confused and misled by the two doctored Interview versions" and flagged Trump's post on Truth Social: "In normal times, what happened on 60 Minutes, (deceptively 'doctoring' her answers), would be THE END OF ANYONE'S CAMPAIGN! … RELEASE THE TAPES FOR THE GOOD OF AMERICA."<sup>18</sup> Americans should know whether President Trump hypocritically called for the end of Kamala Harris's presidential campaign for CBS's

apparently innocuous editing decision, while simultaneously benefitting from and potentially even pressuring Fox News's more egregious manipulation of an interview in his own favor.

In the interest of transparency and accountability to the American public, and to understand whether President Trump or his associates put pressure on Fox News to edit President Trump's June 2, 2024, *Fox & Friends* interview to mislead the public, please provide the following information by July 31, 2025:

- 1. Any communications between Fox News and the Trump 2024 presidential campaign regarding President Trump's June 2, 2024, *Fox & Friends* interview from June 1, 2024, to the present;
- 2. Any communications between Fox News and the Trump 2024 presidential campaign or President Trump regarding Jeffrey Epstein from June 1, 2024, to the present; and
- 3. All internal communications regarding President Trump's June 2, 2025, *Fox & Friends* interview from June 1, 2024, to the present.

The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
