Dear Secretary Lutnick:

I write regarding your recent comments concerning Jeffrey Epstein and your assertion that he was the "greatest blackmailer ever." Your statement, based on your personal knowledge of Jeffrey Epstein, contradicted statements from other senior administration officials, including sworn testimony by FBI Director Kash Patel. The Committee is currently investigating the late Jeffrey Epstein's co-conspirators, the horrific crimes they committed with Mr. Epstein, and the mishandling of the matter by government entities that continues to this very day. In the interest of justice for the victims of Jeffrey Epstein and his enablers, and given your firsthand interactions with and knowledge of Mr. Epstein, we demand that you cooperate with the Committee's investigation by sitting for a transcribed interview with Committee staff.

On Tuesday, a video of your interview on the Pod Force One podcast was posted on YouTube and other social media platforms.<sup>3</sup> During the interview, you recounted an interaction with Jeffrey Epstein—who was your next door neighbor—where you and your wife visited his New York home, witnessed a massage table surrounded with candles, and were told by Mr. Epstein that he received "the right kind of massage" daily.<sup>4</sup> There is substantial evidence that Epstein's abuse of young girls occurred at that residence.<sup>5</sup> Following the encounter, you

described your decision to "never be in the room with that disgusting person ever again."

During your interview, you described Epstein as "the greatest blackmailer ever" and stated, "that's how he had money." In direct contrast to this statement, President Trump's justice department and FBI published a joint memorandum earlier this year in which they claimed they found no credible evidence that Epstein blackmailed prominent individuals. 8

In the interview you also asserted that prominent figures frequently received massages at Epstein's residence, and "what happened in that massage room, I assume, was on video." You continued:

He's a serial sex offender. How could he get 18 months and be able to go to his office during the day and have visitors and stuff? There must have been a trade...So my assumption, I have no knowledge, but my assumption is there was a trade for the videos, because there were people on those videos. <sup>10</sup>

The Committee appreciates your interest in sharing your personal knowledge of Jeffrey Epstein with the American public. Your immediate determination that Epstein was a "disgusting person" based on a single interaction is important. This raises questions whether others in Epstein's longtime orbit, particularly those with ongoing social or professional ties, may have been aware of his abusive behavior. We appreciate that you, like us, are appalled by Epstein's conduct and the lenient treatment he received from former U.S. Attorney Alex Acosta, President Trump's Labor Secretary in his first term, prior to Epstein's death.

The Committee is working to trace the sources of Epstein's wealth and hold accountable those complicit with his crimes—no matter how powerful, wealthy, or well-connected they may be. We urge you to cooperate with the Committee's investigation and provide your knowledge of Jeffrey Epstein and his crimes in a transcribed interview with
